



### **DEPOSIT**

Please confirm your intention to enroll in Davidson's Class of 2029 by the date indicated in your admission letter, and submit your non-refundable deposit as indicated in your application portal, online at admission.davidson.edu/apply/status.

### FINAL ENROLLMENT APPROVAL

As an Early Decision applicant this offer of admission is binding and you must withdraw all applications to other colleges or universities. Your acceptance to Davidson is contingent upon the understanding that you will maintain a standard of academic and personal conduct for the remainder of your senior year that is comparable to your previous record. Your final grades and notice of graduation must be sent to us by July 15, as you will be unable to enroll for courses until they are received.

## **COST OF ATTENDANCE FOR 2025-2026**

Bills for the first semester will be sent electronically in July by the Controller's Office. The comprehensive fees for 2025–2026 are \$87,115 (includes tuition, fees, food, and housing).

# PRE-COLLEGE CREDIT

The Registrar's Transfer Credit and Pre-College Credit webpages contain information about receiving college credit for work you have done in AP, IB, A-Level programs or through dual enrollment. For AP, IB, and A-Level programs examination score reports sent from the national offices to the Registrar are required. Dual enrollment requires two items of documentation. Please read the requirements carefully. If you take a college course in the summer after completing high school, that institution must send your transcript to the Registrar's Office at Davidson. ## **DEFERRAL REQUESTS**

An admitted first-year student may, with permission, defer enrollment for one year. The student must confirm their intent to enroll at Davidson, submit the required enrollment deposit, and a written request for deferral prior to May 1. The request must detail the student's plans for the interim year, inclusive of programs, locations, and dates. If the deferral request is approved, the student must return a signed deferral contract with an additional non-refundable deposit of \$1,500 within one week of the notice of approval.

# FINANCIAL AID AND SCHOLARSHIPS

## **Scholarships**

All accepted applicants, both Early and Regular Decision, are automatically considered for scholarships. Early decision candidates will learn of their selection for scholarships by the end of March.

### **Need-based Grants**

If you submitted all required financial aid application materials on or before your selected application deadline, your financial aid notification will be posted to your application portal at admission.davidson.edu/apply/status on the day you receive your admission letter. If you do not have a notification, you are missing needed financial aid information. If financial need is established, you will receive financial aid, usually consisting of a combination of grants and student employment.
